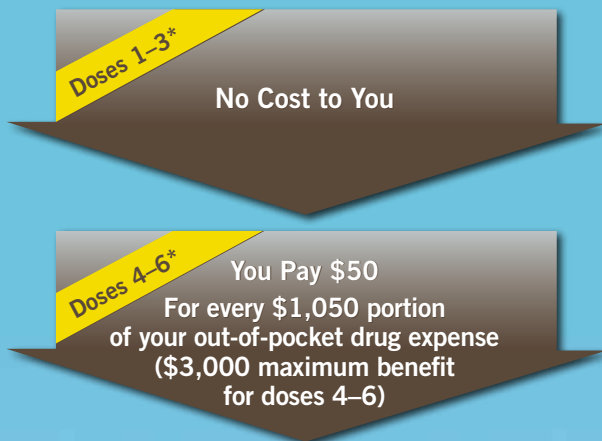


STELARA™ support

Instant Savings Program

Savings off your private insurance co-pay, deductible, and co-insurance medication costs for STELARA™.



- You may be eligible for STELARA™ Support Instant Savings Program benefits if you:
 - Have been prescribed STELARA™;
 - Are being treated for the approved indication for STELARA™; and
 - Currently have commercial insurance that covers medication costs for STELARA™
- Review eligibility requirements and other restrictions
- Call 1-877-STELARA (1-877-783-5272) to obtain your Instant Savings Card

Once activated, use your STELARA™ Support Instant Savings Card when a specialty pharmacy contacts you, or at a retail pharmacy, to receive instant savings off your medication costs for STELARA™.

If using a retail pharmacy, be sure to present your Instant Savings Card each time you fill your prescription for STELARA™.

If your pharmacy is unable to process your Instant Savings Card, or your physician chooses to obtain STELARA™ for you, you can still receive a rebate. Please complete the STELARA™ Support Instant Savings rebate form and return the form with the required documentation.



STELARA™ Support can also help with:

- Explanation of insurance benefits, potential out-of-pocket expenses and sources for other financial support

You can also request:

- Updates and educational materials
- Personalized treatment reminders

Near the end of your benefit period, a specialist may contact you about the extended access program that may be available.

*Program exhausts 12 months after card activation or after 6 doses, whichever comes first.
